## GREATER DALLAS BICYCLISTS

### WAIVER AND RELEASE OF LIABILITY FOR MEMBERSHIP AND RALLY

I ACKNOWLEDGE THAT BY SIGNING THIS DOCUMENT, I AM RELEASING THE GREATER DALLAS BICYCLISTS, ITS MEMBERS, SPONSORS, AND AGENTS FROM LIABILITY. THIS RELEASE IS A CONTRACT WITH LEGAL CONSEQUENCES, AND I HAVE READ IT CAREFULLY BEFORE SIGNING.

I acknowledge that cycling is an inherently dangerous sport and fully realize the dangers of participating in group rides. I FULLY ASSUME THE RISKS ASSOCIATED WITH SUCH PARTICIPATION. For myself, my heirs, executors, administrators, legal representatives, assignees, and successors in interest (collectively "Successors"), I HEREBY WAIVE, RELEASE DISCHARGE, HOLD HARMLESS, PROMISE NOT TO SUE, AND INDEMNIFY the Greater Dallas Bicyclists, its members, ride leaders, officers, sponsors, and agents (collectively the "Released Parties") from any and all claims and causes of action including claims arising from the released parties own negligence, gross negligence, or intentional conduct, or the joint negligence or conduct with any other party or entity resulting in injury or death of any person, or for damage to any property, which I have or which may hereafter accrue to me, and from any and all damages which may be sustained by me, my heirs, executors, administrators, legal representatives, assignees, and/or successors, directly or indirectly in connection with, or arising out of, my participation in or association with an event sponsored by the Greater Dallas Bicyclists. It is the express intention of the parties hereto, both "Successors" and "Released Parties", that the release and indemnity provided for in this document is a full release and indemnity by me, as "successor", to release and indemnify the Greater Dallas Bicyclists, its members, ride leaders, officers, sponsors, and agents as "Released Parties", from the consequences of the "Released Parties" own negligence, whether that negligence is the sole or a concurring cause of any injury, death, or damage. I understand and agree that situations may arise during a ride which may be beyond the immediate control of the leader(s) or organizers of an event, and I must continually ride so as to endanger neither myself nor others. I accept responsibility for the condition and adequacy of my own bicycle equipment. I will wear a helmet that satisfies the requirements of the ANSI Snell regulations that can protect against serious head injury, and I assume all responsibility and liability for the selection of such a helmet. I have no physical or medical condition which to my knowledge would endanger myself or others if I participate in GDB rides or would interfere with my ability to participate in such rides.

I agree that should I or my successors assert my claim in contravention of this agreement, the asserting party shall be liable for the expenses (including legal fees) incurred by the other party or parties in defending. I understand that all riders under the age of 18 must be accompanied by a parent or responsible adult on any GDB ride. If I am a minor, my parent or guardian is also signing on my behalf and we both agree to be bound by the terms of this waiver and release.
